Rate Policies

- **Dynamic Rate Pricing**
- Please note rates are based off BAR which fluctuates according to market demand and occupancy during the contracting period. This above table is an indication of your available Nett rates for our room categories.
- In the case that the Tour operator uses standalone rates, the parties expressly agree that the fixed or Best Available Wholesale Rate will be marked up accordingly within the channel to ensure that rates are never published below the hotels Best Available Rate (BAR) to the end consumer.
- If the onward distribution fails to mark up the BAR rate accordingly, the Tour Operator agrees to remedy the situation with their partner and stand surety for any penalty, should the Best Rate guarantee be in place. Should the Tour Operator fail to remedy the situation, Garonga Safari Co. reserves the right to withdraw the rates.

Group Terms

- 20% of the accommodation value required on bookings of three rooms or more to fully confirm booking.
- The balance is required 180 days prior to arrival.
- The deposit is refundable up to 120 days prior to arrival.

Standard Payment Policy

- Full prepayment required 46 days prior to arrival date, including additional services.
- Booking will be released if not paid timeously with no refund.

Standard Cancellation Policy

- 45 days - day of arrival: 100% cancellation fees (accommodation costs).
- Any additional services paid will be dependent on the T&C's of the service operator regarding refunds.

Provisional Bookings

- Will be held for 14 days.
- An additional 14 days can be added in exceptional circumstances.

Additional Information

- Levies to be pre-paid with accommodation payment. Levies are non-commissionable.
- Credit card payments (MC and Visa only) attract a 3% administration fee. Flywire to be used for convenient payments.
- All bank charges are to be covered by the guest, agent or operator. If a refund is paid by Garonga then the bank charges for the refund will be deducted from the refund payment. Incorrect quotes or charges to the guest will be covered by the booking agent or operator.
- Guests must have full travel insurance that covers all eventualities. Garonga will not be responsible for covering any losses of monies as a result of cancellation.
- Garonga has the right to cancel a booking with no refund should incorrect or inadequate information be given regarding the health and well-being of the guest or guests. The guest or guests must be in good health.
- Should guests who are self-driving or being driven by transfer companies fail to reach the public road entrance to Garonga by 17:00 for whatever reason, access will not be permitted until 07:00 the following day. No refund will be given in this circumstance.
- Guest's arrival times must be given to Garonga reservations during the booking process. If this is unknown it is the responsibility of the booking agent or operator to inform the guests.
- Guests arrival and departure times: It is the responsibility of the Agent to ensure Garonga Reservations have this information at least two weeks before arrival. Garonga is not responsible for self drive guests late arrival after 18:00 whereby access will be denied as per our Safety Rules within the Reserve.
- The Booking Consultant/Agent to please ensure that self drive guests have the correct directions for Garonga and the most updated gate code and are fully aware of the access regulations and timings.
